WHAT DOES IDENTITY INTELLIGENCE GROUP, LLC ("IDIQ") DO WITH YOUR PERSONAL INFORMATION?

Why?

Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.

What?

The types of personal information we collect and share depend on the product or service you have with us. This information can include:

- Social Security number and transaction history
- account balances and payment history
- credit history and credit scores

How?

All financial companies need to share customers' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers' personal information; the reasons Identity Intelligence Group, LLC chooses to share; and whether you can limit this sharing.

What we do

How does IDIQ protect my personal information?

To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.

How does IDIQ collect my personal information?

We collect your personal information, for example, when you

- open an account or give us your income information
- give us contact information or show your government issued ID
- seek financial advice

Why can't I limit all sharing?

Federal law gives you the right to limit only

- sharing for affiliates' everyday business purposes—information about your creditworthiness
- affiliates from using your information to market to you
- sharing for nonaffiliates to market to you

State laws and individual companies may give you additional rights to limit sharing. See our website for additional information.

What happens when I limit sharing for an account I hold jointly with someone else?

Sharing of your information pertaining to that account will be limited as you request, but the other owner's information will not be affected.

Definitions

Affiliates

Companies related by common ownership or control. They can be financial and nonfinancial companies.

Nonaffiliates

Companies not related by common ownership or control. They can be financial and nonfinancial companies.

- Nonaffiliates we share with can include credit unions, insurance companies, direct marketing companies, financial service providers, and credit bureaus and their administrators

Joint marketing

A formal agreement between nonaffiliated financial companies that together market financial products or services to you.

- Our joint marketing partners include credit unions, insurance companies, direct marketing companies, bank sync partners,
